Subject: Inter State Movement of wheat through railways by private entities

Sir/Madam,

Department of Food and Public Distribution (DFPD) vide Order dated 28.03.2024 (copy enclosed) had directed Traders/Wholesalers, Retailers, Big Chain Retailers and Processors in all States and Union Territories to declare their Stock position of Wheat on the wheat stock portal w.e.f. 01.04.2024 and then, on every Friday till further orders. The URL of the Portal developed by DFPD for this purpose is <https://evegoils.nic.in/wsp>.

2. DFPD is maintaining a close watch over the stock position of wheat and to ensure that stocks are regularly and correctly disclosed on the portal by the respective legal entities. As a further step in this direction, DFPD has requested Railways to take an undertaking from the consignee on wheat stock declaration from all private entities/ firms (i.e. Traders/Wholesalers, Retailers, Big Chain Retailers and Processors) which are transporting wheat through Railways.

3. You are accordingly requested to download pdf format from portal with latest wheat stock declaration (enclosed the Specimen Copy-A: "List of storages with stock position" and Specimen Copy-B: "Stock declaration with history- Store Name") made on the DFPD Portal and submit self attested copies to Railways before transporting wheat through Railways.

4. This order shall not be applicable to State Govts., State Procuring Agencies, Government bodies, and FCI.


